Minutes of August 14, 2012 meeting – motion to approve by Mr. Maybury; second by Mr. Daniels. All voted yes. Closed session minutes from August 14, 2012 – motion to approve by Mr Daniels; second by Ms. Chang. All voted yes.

Comments on agenda items

Louis Lopez – asked about the NJ American Water rate increase and about the two ordinances on this evening's agenda.

New Business

NJ American Water – Public Hearings on Rate Increase – will take place here on September 20th at 6 PM. Mr. Maybury would attend the hearing.

Burlington County Chamber of Commerce – Annual State of the County Dinner which would take place on September 24 @ 5:30 at Merion Caterers.

BCCAR – suggested changes to sign ordinance for real estate signage. They had met with Donna and Mayor Camp; signs advertising open houses are severely limited by our

current ordinance and they would like to have these signs allowed to be placed out for a longer time period that what is currently permitted. The Township currently allows signs to be placed 2 hours in advance of the open house and they would like it to be increased to 24 hours before the open house. An ordinance could be drafted; Mr. Daniels made a motion to have Donna prepare the ordinance; Mr. Maybury seconded the motion. All voted yes, Ms. Chang voted no.

- 92-12 Burlington County Future Wastewater Service motion to approve by Mr. Daniels; seconded by Mayor Camp. All voted yes, Mr. Maybury abstained.
- 93-12 Executive Session for discussion of real estate. Motion to approve by Mr. Maybury; seconded by Ms. Chang. All voted yes, Mayor Camp abstained.
- 94-12 Carpenters Agreement motion to approve by Mr. Daniels; seconded by Mr. Maybury.
