RE- ORGANIZATION MEETING

JANUARY 6, 2016 7:00 P.M.

MINUTES

The regularly scheduled meeting of the Westampton Township Land Development Board was held at the Municipal Building on Rancocas Road on January 6, 2016 at 7:00 P.M. The meeting was called to order by Secretary Marion Karp and the opening statement required by Sunshine Law was read. This meeting was advertised in the Burlington County Times on January 6, 2015 and posted in the Municipal Building. All guests were welcomed.

Everyone stood for the Pledge of Allegiance. New Board members Mr. Applegate, Mr. Barger, Ms. Berkley, Mr. Blair, Mr. Daniels and Mr. Lopez were sworn in by Secretary Marion Karp.

Roll Call: Present: Mr. Applegate, Mr. Barger, Mr. Blair, Mr. Borger, Mr. Carugno, Ms. Coe, Mr. Daniels, Mr. Freeman, Mr. Lopez, Mr. Attaway, Ms. Berkley

Motions are needed for the following appointments:

Mr. Daniels made a motion to nominate Mr. Barger for Chairman; the motion was seconded by Mr. Lopez. Ms. Coe made a motion to nominate Mr. Applegate for Chairman; the motion was seconded by Mr. Borger. A roll call vote was taken on the first nomination for Mr. Barger: Mr. Applegate, Mr. Barger, Mr. Blair, Mr. Daniels and Mr. Lopez voted yes; Mr. Borger, Mr. Carugno, Ms. Coe and Mr. Freeman voted no. Mr. Barger would serve as Board Chairman for 2016.

Mr. Lopez made a motion to nominate Mr. Applegate for Vice Chairman; the motion was seconded by Mr. Daniels. Mr. Carugno made a motion to nominate Ms. Coe for Vice Chair; there was no second. A roll call vote was taken on the first nomination for Mr. Applegate: all voted yes, Mr. Applegate abstained.

Mr. Lopez made a motion to nominate Marion Karp for Secretary; the motion was seconded by Mr. Applegate. There were no other nominations. All voted yes.

At this point in time, the Board went into closed session to discuss the appointment of professionals for the 2016 year. The Board came back into open session at 8:07 PM. The Board decided that they would form a subcommittee to get further information from the applicants that had submitted RFPs for the positions of LDB solicitor and engineer. They would report back to the Board with their findings and a special meeting would be held on Wednesday, January 13th at 8 PM, at which time the Board would make their professional appointments.

The minutes of the December 2, 2015 meeting were approved as written.
