Mayor Chang stated that the closed session meeting had been held to address the issue of the head of the EMS/Fire Department.

A motion was made to appoint Jason Carty to the position of Director/Head of EMS/Fire Chief by Committeewoman Teleisa. Committeeman Maybury seconded the motion.

Comments:

Committeeman Thorpe stated he had noted his opinion many times that the appointment should be an internal appointment. He was against the motion.

Committeeman Maybury said there is a need in EMS for a culture change. He had been the liaison for 4 years. They needed some change and to head in the right direction.

Committeeman Daniels stated the Committee in this decision was charged to listen to their neighbors, listen to employees, listen to colleagues, carefully examine resumes, consider all circumstances and rule by law. Gil Gehin-Scott, Second Street had two questions. Wasn't it a conflict for Committeeman Maybury to vote when he was pursuing a head spot at the Mt. Holly MUA and Jason Carty sat on the Mt. Holly MUA board? Mr. Saponaro stated that Jason Carty had resigned from the Mt. Holly MUA Board the past Monday. Mr. Gehin-Scott then asked if the township had made it through the year with the current staff, and with the acting Chief handling both positions, why would we add another \$90,000 position that we cannot afford.

The meeting was closed to public comment.

Committeeman Maybury said the audience has only part of the view. It's different when you're on the inside and know what is going on.

Mayor Chang said there is a need for a culture change and strong leadership in the department. She doesn't say that as an excuse, there are real issues.
