# AN ORDINANCE AMENDING ORDINANCE 12-1992: AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF WESTAMPTON TO PROVIDE FOR LICENSING AND REGULATION OF TOWING AND STORAGE SERVICES

#### **ORDINANCE NO. 9-2023**

WHEREAS, Ordinance number 12-1992 established Chapter 52A of the Township Code of Westampton Township and was subsequently amended as Chapter 224 upon codification through E-Code, and

WHEREAS, section 224-4. Application for license; application fee, subsection B states that all applications for a tow operator's license shall be accompanied by a fee to cover the Township's costs in processing the application, and

WHEREAS, the Chief of Police, or his designee, have determined that the fee must be increased from \$100.00 to \$150.00 to cover the Township's cost in processing the tow operator's application.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee that §224-4 of Chapter 224 of the Westampton Township Code shall be amended as follows:

#### Section 1.

#### §224-4. Application for license; application fee.

**B.** All applications for a tow operator's license shall be accompanied by a fee of \$150.00 to cover the Township's costs in processing the application.

# Section 2.

All other sections of Westampton Code Chapter 224 Towing and Storage shall remain in full force and effect.

# Section 3.

This ordinance shall take effect upon final passage and publication according to law.

# AN ORDINANCE AMENDING CHAPTER 88 OF THE TOWNSHIP CODE OF WESTAMPTON

## **ORDINANCE NO. 10-2023**

WHEREAS, §88-16. G. lists exceptions to Article IV Household and Nonhousehold Animals; and

WHEREAS, the Township Committee of the Township of Westampton wishes to amend Chapter 88 of the Township Code, entitled Animals to include an additional exception for allowance.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee that §88-16 of Chapter 88 of the Westampton Township Code shall be amended as follows:

# Section 1.

# §88-16. Exceptions

**G.** A property in the R-1 Zone, that is no less than one acre in size, may raise or keep no more than 4 poultry hens. Any such hens must be housed in an acceptable coop that will protect from predators and prevent such non-household animals from roaming. Any coop maintained, in accordance with this subsection, must be in a fenced-in portion of the rear yard. Roosters are specifically prohibited.

# Section 2.

All other sections of Westampton Code Chapter 88 Animals shall remain in full force and effect.

#### Section 3.

This ordinance shall take effect upon final passage and publication according to law.
